## RECIPE OF THE MONTH



### **INGREDIENTS**

ght: <mark>Jilli</mark>an, Jaqueline,

- 2 cups all-purpose flour
- 1 Tablespoon baking powder
- 1 Tablespoon granulated sugar
- 1 Tablespoon garlic powder
- <sup>3</sup>/<sub>4</sub> teaspoon kosher salt, divided
- 1 ½ sticks (¾ cup) unsalted butter (divided)
- 1 cup whole milk
- 1 (8oz) package shredded mild cheddar
- <sup>1</sup>/<sub>2</sub> teaspoon dried parsley

### **DIRECTIONS**

1. Preheat oven to 450°F. Line a baking sheet with parchment paper. Add 1 stick of butter to a small microwave safe mixing bowl. Microwave for 30 seconds or until

butter is melted. Set aside.

- 2. In a large mixing bowl combine flour, baking powder, sugar, garlic and 1/2 teaspoon salt. Whisk until well combined. Add butter and milk and whisk just until flour is all wet, do not over mix. Add cheese and fold in with a spoon.
- 3. Drop heaping spoonful's onto baking sheet. Bake for 10-12 minutes, until biscuits are golden brown.
- 4. Meanwhile melt remaining ½ stick of butter in small mixing bowl. Microwave for 30 seconds or until butter is melted. Add 1/4 teaspoon salt and parsley. Stir with pastry
- 5. Remove biscuits from oven, brush with melted butter mixture. Serve and enjoy! Makes approximately 18 biscuits.
