Christmas, when she always served her famed Tomato Pudding. Sweet and savory, this dish has the same consistency as bread pudding and pairs perfectly with turkey and mashed potatoes.

#### INGREDIENTS

- 15 oz can tomato puree
- 2 cups light brown sugar
- 2 teaspoons cornstarch
- □ 1 12oz package Kings Hawaiian rolls (12
- count), cut into cubes
- 2 sticks butter, melted

#### DIRECTIONS

1. Allow bread cubes to sit out on the counter so they become stale (even overnight is OK).

2. Pre-heat oven to 325°F

3. Put bread cubes in greased 8x8 casserole dish.

4. In a saucepan over medium-high heat, melt butter. Once melted, add tomato puree, brown sugar, corn starch, and dash of salt. Stir until brown sugar is dissolved, approximately 5-6 minutes.

5. Pour tomato mixture over the bread and bake uncovered for 45 minutes.

6. Remove from oven and allow to set for at least 10 minutes before serving.
