### RECIPE OF THE MONTH

## Tomato & Smoked Gouda Soup

#### **INGREDIENTS**

- 3 Tablespoons butter
- 1 large onion, halved and sliced
- 2 (28 oz.) cans plum tomatoes, undrained (preferably San Marzano tomatoes)
- 1 cup chicken broth
- 1 cup cream
- 1 teaspoon dried Italian seasoning
- 1/2 teaspoon celery seed
- Salt and pepper to taste
- 1 cup (or a little more) Smoked Gouda, shredded, plus extra for topping.

#### **DIRECTIONS**

In a large pot, melt the butter over medium heat. Saute onion until tender, about 8 minutes. Add tomatoes and broth, and break up tomatoes somewhat with a spoon. Simmer, uncovered for 30 minutes. Use an immersion (stick) blender or a regular blender to pure the onion and tomatoes. Add cream and seasonings. Add cheese, and stir until it's melted. Season with salt and pepper to taste. Ladle into bowls and top with more cheese, if desired. Serve with slices of crusty bread. Serves 6.
