It is with heavy hearts we pay tribute to Quentin Harvey, the 10-year-old grandson of Todd Law paralegal Joyce Pierce, who recently lost his long

battle with an aggressive brain tumor, Diffuse Intrinsic Pontine Glioma (DIPG).

Quentin loved to play sports, video games, and wrestle. He was known to ask thousands of questions, as any curious child does, and he loved spending time with his family, especially his cousins. Even though he was only a 5th grader at Moreland Elementary for a short time, the school rallied around Quentin and deemed him their very own "Superhero." The school has created a number of beautiful tributes, including a memorial tree and plaque, a Spiderman mural, and a special mirror in the boys' bathroom that encourages those in the reflection to "look at yourself and make the change" to "make the world a better place", as Quentin always did.

Quentin was extremely intelligent and won multiple awards from every school he attended. But more importantly, he made friends everywhere he went. No matter what challenges Quentin was facing, he overcame them and lived life with a resilience and fortitude that inspired

DIPG is a tumor that starts in the brain stem, right above the back of the neck and connected to the spine. This part of the brain stem controls some of the body's most vital



functions, like breathing, heart rate, and blood pressure and also controls the nerves and muscles used for seeing, hearing, walking, talking, and eating. Each year, approximately 300 children in the U.S., between the ages of 5 and 9, are diagnosed with DIPG. The tumors can occur at any age of childhood, and although it is rare, can occur in adults. Treatments for DIPG include radiation therapy, chemotherapy, and surgery. Unfortunately, the survival rate remains very low, and there is no cure for DIPG.

May we all work hard to live our lives like Quentin did. Our thoughts and prayers remain with Joyce and her family and we know that the joy and inspiration he brought to the world lives on.

"Are You Doing Everything You Can When Driving To Protect School Kids?"

In order for everyone to stay safe on the roads this school year, we are urging all drivers to remember: **Helpful reminders include:**

- Train your brain to look out for kids. Pay attention to the bus stops in your neighborhood and what time the bus driver picks up in the morning and drops off in the evening. Keep an eye out for kids at intersections and crosswalks, especially near schools.
- Obey school zone speed limits
- Never pass a stopped school bus, even if it does not have its stop sign out or lights flashing. Children could still be getting on or off the bus and crossing the street.



- Look twice before pulling out of a driveway and never rely solely on your car's backup camera or sensors. Small children won't always be on your car's radar, so make sure to double check your blind spots.
- Don't be a distracted driver. Drive as if your own child were at risk: stay off of your phone, keep your eyes on the road, and pay attention.

RECIPE OF THE MONTH

Georgia Peach Cobbler

INGREDIENTS

- 4 cups fresh peaches, sliced
- 1/2 cup sugar
- 1/4 cup light brown sugar
- 1 teaspoon lemon juice

Topping

- 1 cup all purpose flour
- 1/2 cup sugar
- 1/2 teaspoon salt
- 1 tablespoon baking powder
- 4 tablespoons butter melted and cooled to room temperature
- 1 tablespoon vanilla extract
- 3/4 cup milk

DIRECTIONS

- 1. Preheat oven to 375 degrees.
- 2. Add the sliced peaches to a 3 qt ceramic baking dish.
- 3. Add the sugar, light brown sugar, and lemon juice. Stir to coat the peaches in the mixture.
- 4. Bake for 10 minutes.
- 5. While the peaches bake, in a medium size mixing bowl add the flour, sugar, salt and baking powder. Stir to combine
- 6. Pour in the milk, melted butter, and vanilla extract.
- 7. Remove the peaches from the oven and spoon the batter over the top of the baked peaches.
- 8. Continue to bake at 375 for another 35 minutes until the top is crispy and golden brown.
- 9. Serve cobbler warm or room temperature.
