RECIPE OF THE MONTH

Garlic and Ginger Flank Steak

The key to this easy yet flavorful dish is the marinade – the longer it sits, the better! Serve with broccoli or a salad for a light weeknight meal.

INGREDIENTS

- 2lbs flank steak (also called "London Broil" at some grocery stores)
- ³/₄ cup soy sauce
- 3 cloves garlic, chopped (or 2 Tablespoons garlic powder)
- 4-inch piece of ginger, peeled and minced (or 2 Tablespoons ground ginger)
- 3 Tablespoons brown sugar
- Salt and pepper to taste
- 2-3 green onion stalks, chopped, for serving

- 1. Mix together soy sauce, garlic, ginger, brown sugar, salt, and pepper in a gallon sized Ziplock bag. 2. Add steak, press out excess air, and seal bag. Refrigerate and allow to marinate for at least one hour and up to 24 hours.
- 3. Remove steak from fridge at least 20 minutes before grilling to allow it to come up to room temperature. Set aside leftover marinade.
- 4. Preheat grill to medium high heat. Grill steak until medium rare, approximately 4-5 minutes per side, while basting with leftover marinade.
- 5. Once removed from the grill, allow the steak to rest for 10 minutes before slicing and serving. Season with salt and pepper and top with green onions, if desired.

A lot of times the courts require parties to go to mediation, but often people can attend on their own accord to see if the case can be resolved without the need or risk of going to trial. Mediation is when the opposite sides come together with a neutral third party who knows nothing about the case and they try to work with the parties to come to a resolution that both parties can be happy with. When parties settle an issue – no matter what type of case it is – both sides are going to compromise, which makes mediation such a useful tool. Because of this, we often recommend that our clients go through the mediation process so that they have the opportunity to actively participate in the settlement process, versus when you go to court and have a trial before a Judge, the Judge is the one who makes the determination regarding all issues, resulting in less control for the client. Mediation can also be referred to as ADR, or Alternative Dispute Resolution, since it's giving parties an alternate way to resolve their dispute.
