

If your organization needs a small number of helmets, we would be happy to see how we can accommodate!


























### Tell Us About A Great Kid Who Deserves A New Bike!

### **National Safety** & National **Outdoor Month: Important Tips For Safe Bike** Riding





Not only is June National Outdoor Month but it is also National Safety Month. Although it may be hot (ok, very hot!) in Atlanta, get outside and escape the indoors. Make sure to drink lots of water, wear sunscreen, wear your bike helmet, and put on those sunglasses. Also remember these important bike safety tips, compliments of Safe Kids Worldwide:

- 1. Wear a properly-fitted helmet. It is the best way to prevent head injuries and death.
- 2. Ride on the sidewalk when you can. If not, ride in the same direction as traffic as far on the right-hand side as possible.
- 3. Use hand signals and follow the rules of the road. Be predictable by making sure you ride in a straight line and don't swerve between cars.
- 4. Wear bright colors and use lights, especially when riding at night and in the morning. Reflectors on your clothes and bike will
- **5. Ride with your children.** Stick together until you are comfortable that your kids are ready to ride on their own.

### RECIPE OF THE MONTH

## Cowboy Caviar Bean Dip

This tasty treat is versatile enough to serve with tortilla chips, over nachos, or as a salad topper with chicken.

### **INGREDIENTS**

- 1/4 cup olive oil
- 1/4 cup white sugar
- ¹/₄ cup apple cider vinegar
- 1 red bell pepper, diced
- 1 yellow bell pepper, diced
- 1 green bell pepper, diced
- 1 medium sweet onion
- 1 bunch cilantro, chopped

- 1 (14oz) can pinto beans
- 1 (14oz) can black beans
- 1 (14oz) can whole kernel corn (or 2-3 ears of fresh corn)
- One bag tortilla chips

- 1. In a large mixing bowl, whisk together olive oil, sugar, and apple cider vinegar until well-combined.
- 2. Add diced peppers and onions, stir gently.
- 3. Add beans and stir gently.
- 4. Chill in the fridge for at least 30 minutes.
- 5. Serve with tortilla chips.
